

REQUIREMENTS

- Passport
- Photo in white background
- Passing medical fitness test & Emirates ID Biometric
- Health Insurance Card (not obligatory)
- Company License, Share Certificate & Establishment/Immigration Card

Note: Shareholders of Offshore Companies formed in RAKICC, JAFZA Offshore, and AFZA Offshore are not eligible for UAE Resident Visa.

ELIGIBILITY CRITERIA

- Innovators and entrepreneurs in various fields, such as science, technology, research, and innovation
- Successful investors and businesspersons who have a track record of significant investments in the UAE
- Accomplished professionals with a proven track record of at least 10 years in their respective fields
- · Outstanding students
- High-net-worth individuals with substantial financial assets, demonstrated by bank statements, investments, or ownership of companies or real estate assets in the UAE.



PROPERTY INVESTOR VISA DETAILS

ELIGIBILITY CRITERIA

To be eligible for the Dubai Property Investment Visa, you must invest a minimum of AED 750,000 (approximately \$202,000 USD) in Dubai's real estate market to obtain a 2-years Dubai Real Estate Residency Visa, or property(ies) with a value not less than AED 2,000,000 to obtain a 10 year Dubai Golden Visa.







- Police Clearance (if applicable)

FAMILY VISA

FAMILY VISA DETAILS

ELIGIBILITY CRITERIA

- Sponsors must earn at least AED 4,000 or AED 3,000 plus accommodation.
- Family members over the age of 18
 who are being sponsored must pass
 medical fitness tests in approved UAE
 health centres.
- A mother can sponsor her children in exceptional cases approved by the ICP.
- Residents who sponsor their dependents must apply within 60 days of their entry into the UAE.
- If a resident sponsors his parents, the residence visa will be granted annually regardless of the sponsor's visa.
- Medically unfit people will not be granted a residence visa.



ELIGIBILITY CRITERIA

- No Objection Certificate (NOC) from your employer. NOC is also required if you decide to work as a freelance parttime.
- Have obtained a freelance work permit from the Ministry of Human Resources and Emiratization (MOHRE).
- Your minimum educational level is a bachelor's degree, a specialized diploma or equivalent.
- Your annual income from selfemployment for the previous two years is not less than AED 360,000 or its equivalent in foreign currencies





REQUIREMENTS

- Application Form
- Passport copy
- Visa copy (if you are applying from within the UAE)
- Portfolio or sample of work (for media activities)
- Credentials and certificates (for educational activities)


- Valid Trade License

- · Quota and Nationalisation Targets depending on the nature of your business
- Medical Fitness and Health Insurance
- Passport copies, photographs
